For certainty, the matter will be referred to Dol Highways for action as the resident shows no sign of complying with the request to trim overhanging trees which are obscuring a street light on Old Church Road, Other recipients of a similar request have complied with the request.
- 7.4. **Merger with neighbouring Local Authorities** Responses to the initial suggestion have been received from Santon, Patrick and German. Of the three, only Santo expressed an interest in pursuing the matter. A discussion took place and it was resolved to invite Board members of Santon plus their Clerk to meet members of Marown and Clerk at a date to be arranged in late October.
