1. **Apologies** - None received

2. Conflicts of Interest

The Chairman read the agreed text. Mr Lovelady declared an interest in item 4.1 of the Confidential Session (8 Cherry Tree Drive).

4. Minutes

The Minutes of the meeting held on 21 May 2025 were discussed and approved. The Chairman signed the Minutes as a true record.

5. Matters Arising

Hedges – further to previous concerns regarding hedges blocking the pavement posing danger to pedestrians, the Clerk had circulated two draft letters: the first was an initial letter to be given to the houseowner requesting that they arrange for the hedge to be cut and the second a letter noting that no action had been taken and that they are now being served a Notice requiring them to carry out the work within 14 days, failing which they may be liable to a fine and the Commissioners may carry out the work and recover the expenses incurred. After discussion it was agreed that the first letter would be addressed to the Occupier / Homeowner so that they could be handed to the occupier / posted through the letterbox and that they would be given 21 days to undertake the work. If the work is not carried out in that time, then the Clerk will send the second letter.

8.4. Local Government (Amendment) Bill

There was a discussion regarding the above Bill and the proposed new clauses which have caused great concern for Local Authorities, particularly in respect of the potential transfer or imposition of functions on Local Authorities and the requirement to make financial contributions and the lack of confidence in the consultation that would be needed.

Representations have been made to MHKs and discussed in Tynwald. In response, Kirstie Morphet, MLC, requested an Evidence stage, prior to the Clauses Stage of the progression of the Bill through the Legislative Council, to be held on 24 June 2025. Representatives from each Local Authority are invited to attend.

Following discussion between Local Authorities it was agreed to hold a prior meeting on 19 June to discuss the issues involved. Mrs Cox will represent Marown Commissioners at the meeting and

speak at the Evidence Stage.

Mrs Poole-Wilson explained that the Clauses are just enabling clauses and that regulations would still need to be drawn up and this needs to be done in a responsible and consultative way.

The Commissioners' point was that the clauses are not specific and so there is concern about extra functions being imposed on Local Authorities for which there is no funding, leading to a potential increase in rates. The main problem is the lack of faith and trust in Government.

9. Highway Matters

- 9.1. 20mph speed limits
 - The Minister would like to visit each local authority in September or October with a Highways Officer to discuss the proposals. Date to be confirmed.
 - In Marown there are unlikely to be many changes as many residential roads in Marown are already 20mph
 - A big concern however is that, despite this, cars still speed along them and nothing is done
- 9.2. A26 Glen Darragh Road temporary closure 16 -20 June 2025 noted
- 9.3. Parish Walk road closures 21 June 2025 noted

10. Any Other Business

- 10.1. There was discussion regarding the Commissioners' objection to the planning application for a second entrance at Close Jairg Beg, Old Church Road and the use of the phrase "visibility splays" in the Commissioners' letter to the Planning department, although they were unaware of the exact distances required it was felt that this is a matter for DoI. Also the seeming contradiction in that the Commissioners did not object to that for Ballagarey House, Main Road, Glen Vine, though it was explained that the Commissioners were concerned about the loss of parking spaces on Old Church Road, whereas this would not be the case along Main Road, Glen Vine.
- 10.2. There was also discussion in respect of a letter sent to J M Project Management following a complaint regarding Crosby Meadows Estate. Mr Lovelady thought this was unfair treatment as he believed it should have been dealt with verbally to find out the facts rather than in a more official letter. The Clerk explained that the reason a letter was sent was so that it could be seen to

be impartial and that he was not receiving any special treatment just because he was a Commissioner. There is still work to be done on the estate with the remaining houses to be built. A date is awaited for the contractor to connect the estate sewerage system to the new treatment works.

- **10.3.** The Reayrt ny Crink estate has been connected to the new sewage treatment works. The biodisc will be removed and the remaining house will be sold.
- 10.4. A Discharge Licence Application consultation was received for the discharge of treated sewage effluent from the Crosby sewage treatment works to be piped to the River Dhoo. No comment would be made.
- **10.5.** A complaint had been received regarding hedgecutting along the Heritage Trail this is the responsibility of the DoI.
- **10.6.** Lorraine Quayle, Chairman of Marown Memorial Playing Fields Committee, passed on her thanks to the Commissioners for their generous donation towards the Marown Parish Day expenses.
