#### 14. Matters Arising - Not on the agenda

The Clerk spoke with the Rates section regarding residents who have outstanding rates, some from as far back as 2009! The debt is with the Rates section, so they chase those with outstanding rates, though it can be quite a long-winded process from reminders and final notices through to the Attorney General, Summons and Judgment and Execution and finally to the Coroner to enforce the debt. But there is nothing to stop Local Authorities from contacting debtors to encourage them to pay. Clerk to draft letter to send to those with outstanding rates asking them to bring their accounts up to date as they are benefitting from the services the Commissioners provide, without having paid for them. There is currently over £25,000 outstanding to Marown Commissioners!

## 2. Minutes of Previous meeting

The Minutes of the meeting held on 16 October 2024 were discussed and approved. The Chairman signed the Minutes as a true record.

## 4. Planning

#### 4.1. New Applications – the following was considered:

• 24/91112/B - Bridge House, West Baldwin - Erection of 3 tourist camping pods, star gazing platform, sauna and associated drainage and car parking

They are no longer applying to convert the big barn, or have any therapy, just applying for 3 pods. However they are not little pods as the name would suggest, they are actually large, two storey cabins, over 24' x 24', about the size of a new 2-bed house, and likely to cost £100k each. In the previous application Highways were concerned about splays and traffic, but now there are only three pods rather than five, so less traffic. Drainage, grey water, run-off and flooding are major concerns.

It was resolved to object due to their size, their possible future use as residential accommodation, the overdevelopment of the site in the countryside and the flooding risk.

#### 4.2. Amendments and Additional Information

• 24/00713/A - Land adjacent to Main Road, Trollaby Lane and residential area of Strang Road, Union Mills - Application for approval in principle for residential development with access from main road - discussed at August meeting and responded. Site Notices were insufficiently displayed, so the application has been re-published.

- **7.2.** LED Street lighting replacement MUA has confirmed that the work can be completed in two phases probably in January and April, with payment being made over two financial periods, but at a fixed cost.
- **7.3.** Crosby Public Toilet door the suggestion of a sliding door is not feasible as the available width is inadequate. There has been difficulty in obtaining a second quote, so yet another company will be asked. Clerk to draft letter regarding MMPF taking over responsibility for the toilet..

- **8.1.** There was discussion regarding the Clerk's contract of employment and agreement reached.
- **8.2.** Election training for Deputy Returning Officers was attended by the Clerk on 17 October 2024. There will be further training in the new year.

- 9.1. Hedge trimming was discussed with the contractor and he will be asked to continue with the rest of the hedges. It is suggested that Road Sweeping and Gulley Clearing is carried out once the leaves have fallen, from mid-December onwards. His contract finishes on 31 March 2025 and it was agreed to extend it for a further year if he is able to maintain his prices at the current level.
- 9.2. Carol Singing round the tree at 6pm on Monday 16 December 2024. Crosby Silver Band is not happy to play outside the Co-op again as they had a bad experience last year. But they are happy to play at Ballagarey. Christian Forbes offered to print new carol sheets as his contribution.
- 9.3. Mrs Lynch has booked the Commissioners' Christmas meal at The Crosby for 8pm.
