11. Conflicts of Interest

The Chairman read the agreed text. Mrs Lynch declare an interest in item 4.1 of the Confidential Session (Former Manx Motor Museum) and Mr Lovelady declared an interest in item 4.3 of the Confidential Session (Crosby Meadows Estate).

12. Visitors

Inspector Wendy Barker attended the meeting to explain about her role and the Policing priorities. She is in charge of everything outside of Douglas, Onchan and Braddan. She has been in the Police for 29 years, starting in the UK, then moving to IOM and is due to retire in about 3 years. She has a passion for Community Policing and getting to the root of problems, not just dealing with the crimes. She explained that they are short staffed, but that the Chief Inspector is addressing the problem and they anticipate an increase in numbers in May 2025. Many issues involve antisocial behaviour and young people and stem from parents and schools - the Police do some work with schools but hope to do more when staff levels increase. Ports have now come under the Police due to increasing issues with drugs. There is now an armed response vehicle on the road and they have a team of negotiators.

Mrs Cox raised a recent safeguarding issue she dealt with at Marown School where workmen had parked their vehicles on school grounds in the car park immediately adjacent to the playground and were extremely reluctant to move them. They did eventually, but then parked them on the road opposite the entrance to the car park which was not most convenient for school pick up times. Mrs Cox and Mrs Lynch both attended the school to address this issue and both contacted the Police who were not particularly helpful in this matter and did not attend the school. Inspector Barker was concerned to hear this and said she would look into it.

The Western Neighbourhood Policing Team is the mechanism to deal with any local issues in the first instance, but if something needs Inspector Barker's attention then it can be passed to her.

The Commissioners told Inspector Barker that they are very happy to do anything to help support her.

2. Minutes of Previous meeting

The Minutes of the meeting held on 20 November 2024 were discussed and approved. The Chairman signed the Minutes as a true record.

4. Planning

4.1.New Applications – the following were considered:

- 10.1. **Peel & Western Housing Committee –** Mr Miles attended the meeting:
 - 10.1.1. £73,000 lottery money has been received which will be put towards the new care phone system, standalone server, new computers and replacement CCTV cameras.

10.2. Western Civic Amenity Site Board – Mrs Lynch attended the meeting held on 10 December 2024:

- 10.2.1. Because of UK DEFRA regulations regarding WEEE (Waste Electrical and Electronic Equipment) there will be increased charges for disposing of small electrical equipment, microwave size downwards, which will cost £40-50,000/year. The amenity sites have written to the government and said that their budgets have already been set and other LA's have said they won't increase charges. Mr Lovelady suggested that there should be a central place where people can dispose of their small electrical equipment.
- 10.2.2. There has been a saving of £101,446.37 in waste charges by recycling from 1 April 2024 to 10 December 2024.
- 10.2.3. The next meeting is on 14 January 2025.

10.3. Western Area Swimming Pool Board - Mrs Cox attended the meeting:

- 10.3.1. Schools have drastically reduced the number of classes booked, which obviously impacts income, as prices only increase incrementally
- 10.3.2. Café profits are up

- **7.3.** Crosby Public Toilet door another company was contacted but they only deal with upvc and composite and said the door guarantee would be invalidated if the press switch opening mechanism was subsequently fitted.
- **7.4.** The draft Internal Audit Report for 2023-24 has been received and circulated. There were no medium or high risk observations noted.
- **7.5.** The Clerk proposed updating the accounts system to a package such as Quick Books, Sage or Xero, which was a recommendation of the Internal Audit Report. Mrs Lynch suggested talking with the WCAS's bookkeeper.
- **7.6.** The 2025/26 budget needs to be finalised by the end of January. Budget meeting to be held at 7pm on Wednesday 8 January 2025 at the Methodist Church Hall.

8. Clerk to the Commissioners

- 8.1. The employment contract for the Clerk has been signed.
- **8.2.** The Isle of Man Post Redirection Service ends on 31-12-24 the Clerk said it does not need extending as change of address information has been sent out to all relevant contacts.

9. Any other Business

- 9.1. Mrs Lynch said there was a property near Archallagan where the rubbish could not be collected as the car park in which the wagon turns round has fallen trees. She will visit the owners on Saturday.
- 9.2. The Carol Singing round the tree at Ballagarey on Monday 16 December 2024 went well. Many thanks to Mr Forbes for arranging it in liaison with Crosby Silver Band and for providing new carol sheets.
- 9.3. The hedges have been trimmed on Garth Top Road and look good.
- **9.4.** Mr Lovelady has been walking round Ballagarey and knocking on doors and talking to homeowners about hedges that are growing over their boundary onto the road or pavement and that need to be trimmed. A standard letter is needed which can then be put through the letterbox of houses with overgrown hedges giving 14 days for the owners to take action and that if this is not done then enforcement action will be taken.
